



# Equipment Instruction Sheet

## 490 ml Manual Applicator

Item No. 985246

The applicator is fully assembled and ready to dispense 10:1 dual cartridges.

On the 490 ml Manual Applicator select ratio. For extended use, counterbalancing of applicator is recommended.

### 1. Retract Plunger

Press release catch and fully retract plunger.

### 2. Insert dual cartridge

Insert dual cartridge into cartridge tray, ensuring that the locating tab slides into groove. Push down until locked into position.

### 3. Install static mix nozzle

To remove plug from cartridge, leave metal clip in place and unscrew retaining nut. Install mix nozzle (sold separately) on cartridge and secure in place with retaining nut. Dispense product by squeezing trigger. When dispensing is complete, press release catch to relieve pressure.

**Note:** If dispensing is restricted, product may be cured in static mix nozzle. Replace nozzle.

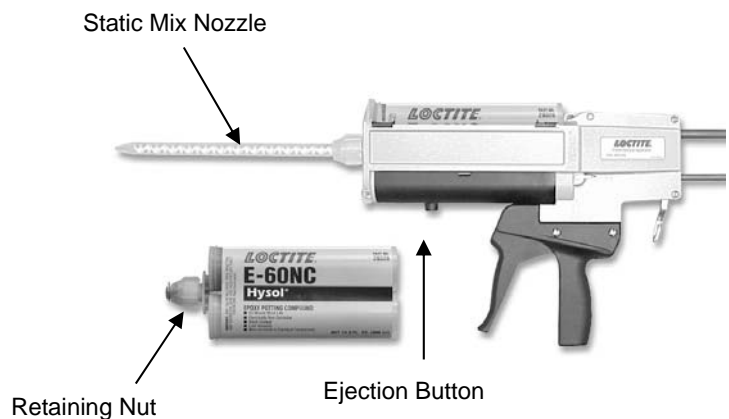
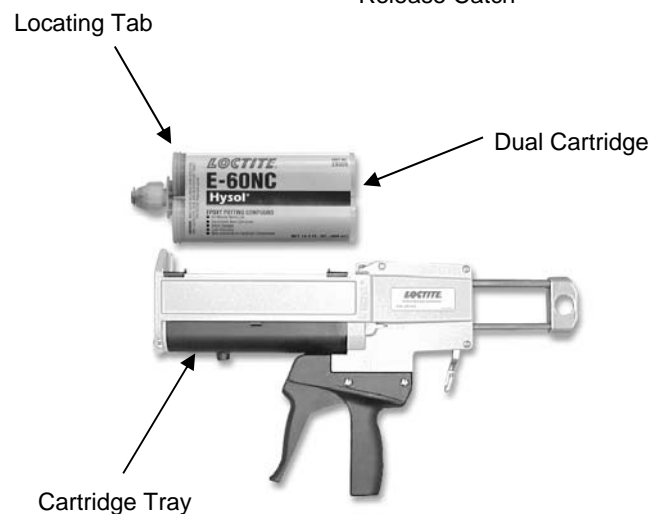
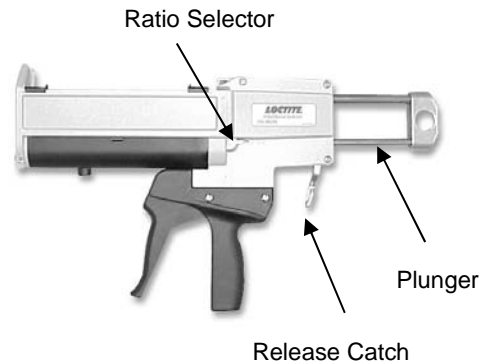
### 4. Removal of cartridge

Press release catch and fully retract plunger. Press ejection button on cartridge tray.
